The registration fees: Each entry Includes Two Poker hands, Two Goodie Bags, Two T-shirts, and Two wrist Bands for Admittance to the Dinner, Band and After Party.

- **Registration on or before July 23rd 2009 - \$150.00 (Includes Poker Run DVD)**

- Additional Poker Hands are \$20.00, a limit of Six additional hands per boat.
- Additional Passengers are \$50.00 per adult, which includes Event T-Shirt, Goodie Bag, Dinner Ticket and Entry to the after Party.

- **Card Turn in:** If you do not finish and turn in your hands to Poker Run headquarters by 8:00 PM, it will be assumed you have dropped out and have forfeited your entry. Exceptions granted: Equipment failure or assisting fellow boater. Poker run officials must be notified by 6:30pm of Participants name(s) and Boat.

There is a 200 boat maximum number of entries. If we reach 200 **paid** entries before the event, no additional entries at the event. Each participating boat must provide a copy of their current hull / liability policy and current boat registration.

- Each driver must sign a waiver that they have not taken any illegal substances nor consumed alcohol 6 (six) hours before an event and will not consume either while driving the boat. Subject to disqualification!
- Each driver and all boat riders must sign a waiver and release. This release state's, "In consideration of being permitted to participate in this event, the participant will not hold Kelly's Port, Lake Racer LLC or any sponsors liable should they be harmed during the event".
- Personal Floatation Devices (PFD's / Life Jackets) are mandatory are are to be worn during this event while operating your boat. All occupants of the boat must wear PFD's.
- The Poker Run is NOT a race. There will be many boats on the lake not part of the run, please respect them. All boats must follow BEHIND the pace boat until released. Passing the pace boat results in disqualification. The morning will be divided into three groups, please stay with your assigned group.
- Each card station shall be considered a NO WAKE area, please approach from the stern at WAKELESS speed. Each station will be open the posted times only
- No refunds will be given; this would not be fair to the other participants. Participants are requested to pray for good weather.

WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to participate in the Kelly's Port 3rd Annual Thunder at the Lake Poker Run event. Herein defined as including but not limited to, the Kelly's Port Marine properties, Lake of the Ozarks PBP Event area's, concessions, and other appurtenant areas where any activity related to the event, or to officiate, observe, work for, or any purpose participate in the Event, each of the Undersigned, for himself and personal representatives assigns, heirs, and next of kin, agrees, and on the direct representation that the Undersigned has, or will immediately inspect such areas, constitute an acknowledgement that the Undersigned inspected areas and that it is safe and reasonably suited for the purposes of the Event for which this Waiver and Release applies and further agrees and warrants that if, at any time the Undersigned is in or about the Event areas and feels anything to be unsafe, the Undersigned will immediately advise the OFFICIALS of such and will leave such areas.

1. HEREBY RELEASES, WAIVES, DISCHARGES, AND CONVENANTS NOT TO SUE the Kelly's Port or Lakeracer LLC Association, it's officers, officials, drivers, volunteers, promoters, advertisers, owners, and lessees of PREMISES used to conduct the event, agencies of government which control essential land and water sites, financiers and firms which render essential service gratis, and each of them, their officers and employees, all for purposes herein referred to as RELEASEES, from all liability to the Undersigned, and the Undersigned's personal representatives, assigns, heirs, and next of kin for all loss of damage, and any claim or demands therefore, on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of RELEASEES or otherwise while the Undersigned is in or upon the EVENT AREAS, and or officiating in, observing, working for, or for any purpose participating in the Event.
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES from any loss, liability, damage, or cost they may incur due to the presence of the Undersigned in or upon the Event Areas, or in any way or officiating in, observing, working for, or for any purpose participating in the Event, and whether caused by the negligence of RELEASEES or otherwise: and
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of RELEASEES or otherwise while in or upon the Event Areas, and/or officiating in, observing, working for, or for any purpose participating in the Event.

THE PARENTS AND/OR GUARDIAN OF MINOR CHILDREN participating in the event and/or engaged in activities around, during or near the event agrees to indemnify and save and hold harmless, the releases and each of them from any loss, liability, damage, cost and attorneys fees they may incur due to the presence of the parent and/or guardian or the minor in any part of the event. The parent and/or guardian further recognize and agree they are executing this Waiver and Release of Liability and Indemnity Agreement on behalf of themselves and on behalf of the minor.

EACH OF THE UNDERSIGNED further expressly agrees that this Waiver and Release of Liability and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS, and is intended to be as broad and inclusive as permitted by the law of the state in which the Event is conducted, and that if any portion thereof is held invalid, it is agreed that the balance notwithstanding, shall continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements, or inducements apart from the foregoing written agreement have been made.

1. **NO PASSING** of the Pace Boats until the checkered flag has been dropped. **NO EXCEPTIONS.** If you pass the Pace Boat before the flag is dropped you will be disqualified and forfeit all of your poker hands and those of your passengers.
2. **CARD TURN IN** starts at 5:30pm and ends at 8:00pm. The only exceptions: Equipment failure or assisting a fellow boater on the water. Poker run officials must be notified by 6:30pm of Participants name(s) and Boat.
3. **DO NOT OPEN** poker card envelopes. If your envelopes have been opened you will be disqualified and forfeit all of your poker hands.
4. **NO CONSUMPTION OF ALCOHOL** by the driver of each boat during this event. If the driver is caught drinking during this event he/she and all passengers will be disqualified and forfeit all of your poker hands.
